

## BRAINWASHING AND ITS CONSEQUENCES

### INTRODUCTION:

As most of us realise there are numerous ways to manipulate people's thoughts and beliefs. Propaganda and lies can be delivered through education, literature, the media and so on. In particular, the status of public figures of all sorts allows them to be used in the brainwashing process, especially if they've been criminally compromised. Those who haven't been compromised can be monitored by agency operatives and their organized crime counterparts but most of the agency victims are usually non public figures who've expressed just, peaceful, honest views which conflict with those of the powerful and the wealthy. The resultant silencing and discreditation of these targets allows information to be suppressed; kept from the general public. To understand fully what follows you must first concede that we have all been mushroomed and brainwashed on certain matters.

### PSYCHOPOLITICS:

This is the false labeling of targets as "crazy", to stop them questioning or commenting on the criminal activities of the ruling class. "Mental healing", indoctrinating these people until they accept the narrow, elitist wisdom of their "masters", is a covert enslavement procedure covered by excuses and lies. Sadly, as with many things channeled through the corrupt mainstream media, the public don't realise this goes on let alone that public figures can help to support, hide and foster it. The use of corrupt or ignorant psychiatrists and officials is a classic example of deception on a grand scale... Yet the problems they create are no less than those caused by ignorant/corrupt police etc.

### PSYCHOPOLITICS IN A DEMOCRACY:

In reality we have democracy in name only. Advocates of real democracy will attest to that. Freedom of thought and expression is restricted (on many important matters) to the ruling class and then only allowed where the individual is of the same mind as the group. Censorship (suppression through oppression) often insulates the rest of us from other views and the truth. In this way minority views can actually outweigh majority opinion. Those trying to break that barrier can become victims of conspiracies of silence that may lead to unemployment, impoverishment or worse.

Those fielding the complaints from harassed advocates of true democracy (i.e. the police, doctors, family etc) often disbelieve the victim's story because covert attacks leave little or no evidence. Most victims learn to suffer in silence but at the other extreme suicides have occurred. Many are also institutionalized either for taking matters into their own hands or for being discredited under a corrupt system of political psychiatry. This "system" involves corrupt MP's, journalists, beaurocrats, police and psychiatrists.

Particularly disturbing is the public veneration of psych' professionals to the point where whatever they say or diagnose is accepted, even when it's clear they are discrediting political/ideological targets pinpointed by their clients or employers. The public has been brainwashed on this matter. The Church of Scientology and The Christian Scientists (amongst others) point this out but are largely ignored by the complicit media on this topic (whilst attacked on other matters).

Another problem is professional ego. Psychiatrists can become absorbed/blinkered and assume that they have the answers to a situation when they don't even understand it. This leads to injustice born of ignorance, regardless of any complicity. In one respect, if certain "patients" weren't paranoid (and needed Federal Police help instead) most psychiatrists would still rather dismiss that possibility because of their ego. Aside from disempowering them this would also mean losing some of their income. Even if they're not a corrupt psych operator this ego/money concern is professionally dishonest. A real victim needs real help from the authorities not a disbelieving, discrediting psychiatrist.

On the matter of how frequently people are covertly monstered by agencies/criminals... the reader should note that the communist KGB agency boasted that they had forced tens of thousands of suicides by covertly harassing/discrediting innocent citizens. And the west is no better. We've mimicked and embraced the old Soviet methodology, employing superior remote technology (like satellites) along the way. In the west the focus is on calling people "mad" rather than actually driving them to madness but, since those institutionalised are destroyed just as efficiently as if they were killed, there's little difference. By stopping short of murder it also allows clearer consciences (especially for any public figures involved that may be in denial about their roles) and also ensures there are fewer martyrs to any cause (be it democracy, privacy, morality, peace etc).

Now, public figures can be easily conditioned to believe that they are superior citizens. Couple that with the compromises in morality that can be effected by a ready supply of money, drugs, sex or whatever and you have a powerful group of people that "they" can use. It's only a matter of time until the attitude and lifestyle combine making many believe that they are above the law and the rest of society; especially if they work for/with organised crime... And, in fact, this is not just a belief... police tell me they cannot (usually) investigate serious crimes involving suspects with public figure status and/or "connections." They make themselves unavailable and scream police harassment if continually approached. Their execs, employers, lawyers etc can get involved and senior police can receive warnings until the matter is dropped. These warnings can be direct or indirect/covert; e.g. in the case of the media, "timely" stories on police corruption may be run. Aside from such journo-terrorism they can use illegal surveillance feedback as well.

Entertainers, be they singers, actors or sportsman (etc) can lose career opportunities if they question the illegal practices around them and may even be set up by the media mafia for shame/humiliation. For those "puppeteered" (due to the erosion of their own integrity) involvement in harassment crimes becomes easier and easier but, for the rest, life is comfortable and they don't care enough to get angry or oppose the corruption/crime surrounding them.

The victims of harassment, mental intrusions and so on are, like everyone else, brainwashed into believing the public "acts" of most of these celebrities. With respect to the big issues this is a serious problem because many public figures benefit from things like illegal surveillance and the persecution of anti-crime campaigners. Their complicity extends to "experiments in control" being trialed on these targets. For many celebrities, their regard/respect for these victims and their human rights (in fact the law itself) is extremely poor. Some even delude themselves into believing that the targets are either

guilty of something or can be provoked into criminal conduct. Couple that with a refusal to converse with these people and you've created the ideal atmosphere for class oppressive crimes. For example, Ch 7, Australia runs a "Crime stoppers" program with state police but executives and others have also used this to lodge false complaints about certain whistleblowers and so on; to silence/discredit them. One paedophile network informant was house-bound for weeks when she learned that police had been told by Ch 7 that she had a rifle and was about to rob a local bank. The notion was absolutely absurd but, fearing a set up, it sent her to ground just when she needed to be most active about the matter in question.

Another loathsome practice involves baiting targets with positive feedback or feigned sympathy. Sometimes this can be done by someone who is actually a harasser themselves. For instance, TV presenter J. Wendt is one of the people that media/agency victims have approached for help. (She has even attended whistle blower functions etc as a cover). To their astonishment not only did she fail to help any of them but she (and her exec colleagues) had them all wrongly institutionalized at Cumberland psych hospital; courtesy of a small group consisting of corrupt police, psychiatrists and nurses. When questioned on this practice one psych nurse told me that "that's what they do to anyone that crosses them." The perplexed reader must remember that without control of media outlets and media personnel the agencies and crime bosses cannot suppress information or spread misinformation on vital matters. If not for operatives and other complicit criminals in the media ranks (as well as the political and business ranks) the ugly truth may surface on many matters which would concern and anger the general public. This then is another example of how our democratic, legal and social systems fail miserably when put to the simplest of tests. It's bad enough that people in positions of influence refuse to help victims but to actively take part in media feedback as well as false complaints to police etc is criminal conduct that can be neither forgiven nor forgotten especially as the criminals involved are repeatedly offending whilst enjoying a free reign within the system.

#### BRAINWASHING THE BRAINWASHERS (et al):

For controllers, the first step is to involve or brainwash the psych professionals, the medicos, the MP's, entertainers etc. Many are already corrupt when they start out so that part is simple but, for the others, the focus is their ego. Most are very happy to believe that their training, talent and experience justifies their status, wealth etc. However, the truth is many are just "guns for hire" who'll do whatever they are asked to do by their employers or clients (whoever they may be). Placing a professional rubber stamp on whatever decision their remunerators make is, of course, not only unprofessional but often criminal conduct. To some it's just "business," but it's criminal business; to the detriment of others.

In their psych education students are trained to study behavioral patterns (be they abnormal or merely eccentric) and categorise mental disorders (be they actual or manufactured). Naturally, if you have an influential citizen (or group of influential co-conspirators) who are covertly harassing a target that victim may appear paranoid; because there is no evidence of the crimes they've endured and often no apparent reason for them. At the same time the guilty/threatened criminals who harassed the target, (whether their concerns be real or paranoid) will not be vexed and will simply ignore or

deny any accusations of wrongdoing. In this manner wealthy criminals are assisted in running protected operations not only by fellow criminals and agency operatives but by the dubious findings of psych operators.

The counter accusations, which are ignored, could include “deluded megalomania” but these control freaks are more bad than mad; wealthy recidivists with much to hide and lose. To break their criminal associations would mean losing the many benefits that they bring. This is why the public is brainwashed into accepting the nonsense dished up by psych operators who question the sanity of decent, sane people; i.e. to silence them. The media effect all of this with positive reinforcement of psych professionals roles and campaigns, like the recent ads claiming that one in ten citizens will suffer from some sort of mental disorder in their lifetime. Embellished research figures and flawed diagnoses (designed to feed money and control into the relevant coffers) are undoubtedly behind this but they make accusations regarding psychotic episodes easier for the general public to accept. That’s very dangerous when you have unscrupulous, wealthy criminals using psych operators to dispose of targets via similar misdiagnoses. Again, cries of “rubbish”, “political psychiatry” or anything else can fall on deaf ears because of this and other people become afraid to support the target, fearing shame by association.

These psych operators now lurk amongst the professional psych ranks and elsewhere, acting as a cancer to destroy what little truth or integrity remains on certain taboo matters (matters that ought to be discussed openly). Honest, informed or independent thinkers who see past the propaganda/brainwashing of the thought police are rendered useless by such people.

A specific example of brainwashing the brainwashers (esp. psychiatrists) is the textbook coverage of the condition called “paranoid schizophrenia.” Students and practitioners are told it’s a common disorder evidenced by feelings of persecution, mood swings etc which, largely, also describe what any knowledgeable law enforcer would expect to find from the victims of covert crime. However, the psychiatric fraternity is told nothing about the methods/technology available to covert agencies and organized crime figures. They are not told about the vetting and corruption of people entering public life (people who could otherwise do something about the criminal activities in question). And they are not informed that “operators” harass innocent, private citizens (mercilessly) if they question or criticize lucrative criminal practices from which their masters profit. So what many lay people recognize as a Federal Police matter can easily become the concern of ignorant (or corrupt) psych professionals seeking control and remuneration.

Even more specifically... one special symptom of “paranoid schizophrenia” is the hearing of voices in the head. Now, there is a device called a neurophone (invented in 1959) which has been secretly developed by the U.S military (and others). This technology allows live/recorded, computer-driven voices/noise to be directed into the brain via microwaves or remote satellite laser. It acts like a ventriloquist but the thrown voices bypass the ear nerves, traveling the nervous system instead to the brain and they are only heard by the target. This can act as a brainwashing tool (like hypnotic tapes used to overcome phobias) or a mere annoyance. The technology is accessed now by organized crime, the media mafia, corrupt MP’s, beaurocrats, captains of industry etc. etc... all courtesy of corrupt agencies and defense contractors. It is used to confuse,

torture, rob, ridicule and discredit targets. The victims usually approach ignorant/culpable local police, doctors, journalists or politicians for help and are either ignored or institutionalized; listed as paranoid with auditory hallucinations. The correct move would be to contact human rights activists or honest Federal police but naïve victims don't initially realise that many community "leaders" are phonies who'll sell them out without a second thought.

Notably, the average duration of the sort of covert harassment mentioned here is fifteen years, according to senior Federal police. This is, not so coincidentally, the textbook average for bouts of paranoid schizophrenia, a term originally promoted to cover for the disposal/discrediting of ex-spy agency whistleblowers. So, without proof, this would neatly cover 15 years of experimentation, torture and harassment except that many victims suffer 30 years plus, most permanently. The classic cover and public brainwash on this one was evidenced in the movie "A Beautiful Mind" but in reality the target was attacked and discredited using neurophone technologies.

So, by getting people to accept this psycho nonsense (to explain away victims traumas) half the brainwashing job is already done on the general public as well. The rest involves their absorption of other media twists and half truths along with a strict control of information on technologies, high level crime etc. Therefore, whilst people are aware of remarkable things like air and space travel, telecommunications and various power supplies (and accept them readily) due to the suppression of information they are NOT aware of other inventions like those derived from neurophone and brainwave scanning devices. These have facilitated illegal medical, military and "other" research for decades. They allow anything from discrediting, criminal attacks by unseen tormentors through to hidden computer screen (and wall plate) brainwave scanning. Ultimately there's now satellite delivery for most of these and more. The goon squads responsible work closely with psych operators in learning how to control their targets. Their own brainwashing no doubt consists of experience coupled with basic dehumanisation.

#### (BRAVE) NEW WORLD (EXECUTIVE) ORDERS:

To keep such heinous crimes a secret any real threat to corrupt agencies or organised crime may be killed. Warmongers and terrorist scammers in the military and the agencies (like the CIA etc) have had many good people murdered; just like the mafia and others. They're usually public figures (like the Kennedy's) but if they're not, yet would have spoken with authority given half a chance, they can also be permanently silenced. One such person was Australian psychiatrist and justice advocate, Dr Alistair Stewart. A rarity in his profession, an honest/decent man, Dr Stewart was murdered whilst attempting to blow the whistle on the number of political psychiatry victims languishing in asylums. Threats and a smear campaign could not dissuade him so he paid the ultimate price for caring. Another murdered man was Mr. Bill Roy, lecturer and chief technician at Canberra's Black Mountain Tower. He tried to enter politics to expose Big Brother agencies and their satellite spying on innocent citizens (spying which betrays those people to protect/foster criminal activities). If the technology was accessed by honest law enforcers then terrorism, the drug trade arms trade and a multitude of vices could be wiped out. The problem is "they" profit from all of this; that is, the agencies, the military, big "business," and the media mafia. "They" don't want the general public

learning the ugly truth. It's one of their biggest secrets and they'll kill people like Bill Roy to keep it that way.

Other known instances of murdered experts include an array of (ab)used scientists who died mysteriously after working on various classified military projects. Like ex defence personnel, government MP's and prominent entertainers such scientists are monitored very closely (by satellite). If they even think about whistleblowing they'll be dealt with. "National Security" is, of course, used to shield what is already a gross misuse of public funds (esp. in the U.S.A). In particular, criminally inspired projects (like HAARP) that are designed to create, test and use weapons of mass destruction, (including directed energy and personal harassment technologies) simply wouldn't be condoned.

So, whilst brainwashing public figures and psychiatrists (many of whom talk to plants and animals and contemplate their own sanity daily) is a big part of silencing those totally sane, intelligent people who are not deceived, the principal aim is to effectively brainwash the vast majority. The adulation and trust afforded criminals in public life is the main obstacle because, ultimately, it's through these people that suppression, misinformation, oppression and worse are effected.

#### MORE SERIOUS BRAINWASHING:

In recent times western "businessmen" are more and more to blame for brainwashing but political parties (The Nazi's, Fascists, Communists) still cop the flak in our literature. The fact is all war is organized madness, the justification for and glorification of which is a cruel, financially motivated manipulation of the general population. Fear and hatred get channeled through a patriotic funnel then stirred continuously by the propaganda delivered by skilled orators and brain washers. It's true, if those to gain by war had to fight it themselves peace would be the norm just as it would be if the full truth were known about the reasons for conflicts and the alternatives offered by diplomacy and technology.

Elected officials have no mandate to lie or accept the lies of others (including agency representatives with hidden agendas). MP's are chosen to serve not rule and to serve the best interests of the majority not just some vested interest groups. Of course, any government failing to bend to the will of influential groups/individuals may not survive too long but, then again, they may survive even longer given greater public support... who knows... nobody's tried.

Today, thanks to a few in the entertainment industry, the communicated horror and futility of war has eroded the enthusiasm for it but lies of fact and omission remain. Of particular concern are the heightened terrorist attacks orchestrated in recent years. Again, as with "professionals" dealing with more mundane matters, the military/agency experts hijack the debate on the war on terrorism, feeding the politicians accordingly. This is why "trust me" doesn't work on those who know what can go on. And who profits? Again, arms dealers, multinationals, the military and spy agencies (funding and control for these always escalates) and so on. However if the available technology was used to help stop war/crime that funding could be cut.

An insight into how our controllers think was found in some old KGB education papers that someone sent to me. This megalomaniacal rubbish went on and on about controlling the hearts and minds of the people so as to make them susceptible to

propaganda. Question the rhetoric and you would be defamed, degraded and violated horrendously, unless and until you were mentally enslaved like everyone else (or at least pretended to be). Simply put, the minority views of the wealthy, criminal elite must be accepted or else. And make no mistake, the mentality and objectives of the West's New World Order is no different, other than the use of more clandestine methods. This is so because jack booting their way into peoples bedrooms in the early hours of the morning to drag out, torture and destroy "dissidents" (honest, decent people) is not acceptable in a "democracy". Instead they organise satellite tracking, neurophone voices, brain scanning, EEG cloning and directed energy weapons attacks as well as assaults using their microwave and ground-based equivalents. These leave no evidence, no trail to follow.

Also noteworthy in the KGB nonsense was the notion that humans are just clever animals (ala Darwin's theories). The implications including that we have no nobility, integrity, character or spirit; no other/religious purpose, only functions. In the west this greatly pleases those espousing philosophies akin to the "law of the jungle," or the "crime pays" mentality of many so-called "successful" criminals. Those embracing spirituality, honesty, morality, equity and so on are seen by these people as losers, compensating for their inadequacies. With such warped thinking it's a wonder that the old soviet regime didn't attack Christianity itself by claiming that since the Christian god is three persons in one he must be a schizoid entity.

This evil KGB material concluded: "All men's individualistic reactions are the product of mental derangement. The populace must be brought into the belief that every individual within it who rebels in ANY way, shape or form (especially against efforts and activities to ENSLAVE the whole) must be considered to be a deranged person whose eccentricities are neurotic or insane and who must have at once, the treatment of a psychopolitician". (Luckily for Lincoln he wasn't born Russian but the good ones get killed anyway don't they...). Again, it's no different here and now, in the "democratic" west. The methods are just hidden from public view. The only evidence is provided by timely media attacks on the few celebrities who've spoken out and offended powerful criminal identities. For the rest, they're set up and knocked down privately by the corrupt agencies and the media mafia. Never forget that over two-thirds of all media stories never surface but they often work on harassing the people involved in a criminal fashion; it's an unseen part of the media's function.

Finally, on technological advances... subliminal messages can be delivered/planted using telecommunications, music, ads etc. EEG cloning of individual/group patterns can be fed back to induce anger, sadness, mirth and so on. It's a control freaks dream come true and these evil technologies are accessed by powerful criminals including media personnel. The public needs to be made aware of all of this and become more reluctant to accept what they hear, read, see etc. People must think for themselves.

### PSYCHOPOLITICS AND THE MEDIA ROLE

Without doubt, for most people, it is the mainstream mass media that dictates how they think. A narrow band of elitist opinions (on major issues) is the limit of what's tolerated regardless of what informed majority opinion would be if the full truth was known.

Where there is conflicting information political psychiatry is employed, in part courtesy of the “learned” opinions of psycho politicians, through both fictional and non-fictional writings and presentations. Entertainers and other public figures further promote psychiatrists by using them to cope with the demands placed on them. For others this makes it easier to accept that breakdowns or psychotic episodes (and so on) are occurring when it may just be an ordinary emotional response to harassment (self defence) that’s involved. Still, the threat (the chance of a smear) helps keep whistleblowers and others at bay. And remember, the media only publicly reports a small fraction of what they know, the rest involves monitoring/harassment of victims, mostly good people.

Common sense says that when provoked peoples responses depend on their experiences, personality, character, intelligence, moral code etc etc. In, say, a TV interview taping, a public figure would be more guarded than most, being aware of editing, provocation, contextual blurring and other journalist “tricks”. So he/she may laugh off untruths more calmly than an indignant layperson who is also in a vulnerable position but as an inexperienced, unknown dupe. Regardless, any idea that responses should be the same (textbook) is seriously flawed. If anything the one dimensional, “acted” response is more questionable. However, status and connection strengthen the celebrities position and their established cons; they’re not schizo, only two-faced.

Regarding mass brainwashing by the media an excellent example is the acceptance of alien life. Military, agency, scientific and other “experts” have debated this for decades with most citizens now believing it is arrogant to assume that we are alone in the universe. However, early last century your sanity would’ve been questioned if you even raised the topic aside from discussion of fictional sci-fi works. The effective brainwashing on this has been mass media driven (esp. movies) and has paved the way for ever increasing agency funding which has, in reality, found it’s way into more sinister government and non-government programmes. Some of the illegal programmes (also funded by drug/blood money) even involve alien and psychic scams. Those responsible for these scams are pleased with the scale of their deceptions but they still want to brand the deceived victims as mad. If you really believed their nonsense (on aliens) you could jest that they want the best of both worlds.

On planted thoughts/ideas/opinions... take this “alien” business a step further... Say our Earth is one of the few that can sustain life i.e. assume for argument sake there are others. The likelihood of superior life forms finding us (and we certainly can’t find them) AND traveling vast distances to visit AND sharing knowledge willingly is remote in the extreme. Even if they were infinitely tolerant... we are not. We can’t even make concessions for our own neighbours let alone space aliens. So, fantasy aside, be they friend or foe it would all end in total disaster. So why spend huge amounts of money funding NASA, the military and spy agencies? Especially when the money is largely redirected to the testing/use of barbaric methods to control/oppress the citizenry.

So where are the media watchdogs on this? Are they running exposes on misappropriations of taxpayer funds (principally in the U.S.A)? Are they exclaiming at length about the gross human rights abuses and crimes committed on ordinary citizens? No. They’re covering up... even participating in the covert harassment of those who object on behalf of us all. Their favoured method is media feedback...

Media feedback entails taking the results of illegal, high tech surveillance (audio/visual) and threading them into news, current affairs, music, movies, commentary

etc. The resultant “coincidences” swamp the target initially; to ensure they realise that they are being robbed, ridiculed, terrorized and studied. The surveillance is often arranged by corrupt agency operatives connected to organised crime, corrupt politicians/bureaucrats etc. The surveillance frequencies are made available to media technicians who just tune-in, live. Other results (e.g. from neurophone/brainscanning) are relayed. The trickery and harassment orchestrated as a result of all of this discredits and silences many people who question mafia/political/media personnel or their profiteering from human misery (created by drugs, weapons sales or other lucrative concerns). Since average, honest people are excluded from high-level decision making “they” also use the surveillance to keep in touch with the views of ordinary citizens. Yet it is also hoped that harassed victims will stop listening/viewing for fear that they will pick up on (and relay information relating to) media lies/scams etc. They may also want the monitors to ignore their media programme(s), which they’ll pick up on if the target is viewing/listening whilst being spied on.

A brief example of feedback follows: A DJ played “Little voice (inside my head)” by H.Duff. It’s one of many songs which subtly refers to neurophone harassment. The DJ exclaimed, after the song, that the voice in her head would like to beat the crap out of a listener (female). This reference to an harassed listener that they know (from surveillance) was listening at that time is typical of what can happen 100’s of times per day (per victim) along with more overt harassment from corrupt pilots, cops and so on. It’s part of a protected operation, like drugs, vice or any other organized crime. They’re not only free from investigation they’ll harass anyone who even criticizes or disagrees with their crimes.

Another worrying sort of feedback involves public input on criminal investigations, contentious issues, scripts, inventions, ideas, competitions and writings of all kinds. Media mafia requests for these things are often a trap. Remember, you cannot control the world if you don’t control the media, and “they” do. So, when you inform on a drug pusher or submit an anti-crime work etc you are likely to be addressing it to a criminal working with compromised “actors” in the media. The public trust these people and believe their stated intentions mainly because they observe that some feedback is applauded/credited (as a cover)... Letters to the editor are aired, scripts credited, winners announced but the world stage is also a means of luring others into danger. As well as this, Echelon satellite monitoring means that all telecommunications can be intercepted by U.S. agency personnel and/or their criminal associates. Honest police, etc are also watched closely by satellite and in house operatives (put in place before or after they enter their career/profession). The whole operation is protected. And until the brainwave monitoring covers all citizens (like Echelon) media “feedback” will be one of the better ways to single out dangerously honest citizens for torture etc.

So, the media is more of a source of terrorism than a source of truth as everything is timed to blackmail, harass and control. Criminals control the media to distract us with gossip/stories while some of the most important matters are ignored. Legitimate items and half-truths conceal the herding; it’s all mushrooming and betrayal of the public’s trust on a grand scale.

Again, the media does mould our thinking: our attitudes, goals, fears and more. If a public figure threatens to expose a harsh truth they can be humiliated or worse by the media who’ll never let the truth get in the way of a good crucifixion. Good examples

include the recent attacks on wildlife conservationist Steve Irwin and the treatment of sportsman, Anthony Mundine. Mundine's comments on the Middle East terrorist situation and September 11 led to a live Ch 9 transmission being cut so that the audience couldn't hear his views in context. This is not democracy at work.

#### ILLEGAL RESEARCH ON THOSE NOT BRAINWASHED:

It's worth reiterating: Like any habitual offender, (any recidivist), wealthy criminals have a total lack of respect for the law, their fellow citizens and those citizens' rights. Offering up anti-crime writers, human rights advocates, whistleblowers etc for set ups, threats, smear campaigns, blackmail and tricks doesn't concern them. The victims they target are subjected to cruel, inhuman experiments in control using directed energy, scalar and vortex weaponry as well as neurophone, brain scanning, and brain fingerprinting technologies.

The "agencies" and others study the thoughts and actions of their prey remotely, using satellite surveillance/harassment technologies. They try to control and/or predict behavioural responses using their goons and psycho-politicians. Even people who simply write to a (monitored) MP can end up in these programs depending on their grievance. The neurophone trickery is common with the Privacy Commissioners people telling me that the single most common complaint they get is about TVs/radios working when turned off; a first stage neurophone trick.

The victimisers like to deny their role, trying to laugh off references to the suffering they've instigated and ignoring the misfortunes inflicted by their lackies, but "honest" police, political aids, agency personnel and journalists confirm that this sort of crime is not uncommon.

The technologies mentioned facilitate remote pain and provocation studies, public deception experiments as well as dream, memory and thought analysis (and computer storage thereof). Robotics, cloning and computer "brain" research also benefit. The scams employed usually center around neurophone lies and involve communications with computers/operators claiming to be anything from God to Satan, from dead relatives to time travelers, from neighbours to invisible men. It's all utter rubbish and those who believe their tricks can be institutionalised. Worse still, horrific crimes and terrorism can be provoked when violent, criminally bent people are targeted as part of a cross sectional study on the community. Some, have clearly been used as Manchurian candidates. Timothy McVeigh (the Oklahoma City bomber), John Chapman (John Lennon's murderer), Martin Bryant (Port Arthur massacre) and David Koresh (Waco siege) were all triggered for political, funding and control purposes of one sort or another. So who is to blame... Dr Frankenstein or the monster? The sadistic fiends responsible, like the terrorists and murderers they provoked, are all guilty of crimes against humanity; as evil as any war criminals you could name.

As difficult as it is for those of us who are not criminally insane to understand, the sort of people who do these things are totally deluded. An insight into the mentality of such monsters (especially the scientists) can be found in the writings of Dr Joseph Delgado, implant pioneer and inventor of the stimoceiver. This warped individual was one of the first advocates of mind control experiments, involving the torture and brainwashing of spy agency targets. He said that to gain total loyalty for a system that was clearly corrupt stimuli re specific cerebral structures was needed. In this way social

behaviour could be suitably “modified” along with appropriate emotional/mental responses. The reactions could also be monitored... “You can even follow intentions, the development of thought and visual experiences” boasted Delgado, alluding to mind reading capabilities which were not perfected until the later development of computer software programs with complete brainwave vocabularies (to interpret/decipher the scanned brainwave patterns).

Today, U.S. defense contractors and others are decades ahead of the academics thanks to the U.S. government secrecy orders re the technology as well as the media complicity and tax payers money. E.g.. Computer chips have already been fused with living brain cells... Hippo-campal neuron patterning grows neurons onto microchips and could conceivably facilitate the creation of zombie armies of robots, clones or humans. Unlike remote satellite mind “interference” (I personally believe total “control” is impossible) such direct methods could actually lead to something close to complete control.

On top of this DNA/IVF research (and more) may not only lead to designer babies but the use of clones for deception, body parts and further inhuman experimentation. Enlisted personnel are also at great risk in all of this. Lawyers acting for U.S soldiers have already noted that military records failed to record “vaccinations” ordered prior to active service in the Middle East. No prize for guessing why they don’t. U.S soldiers are just as likely to be subjected to involuntary experimentation as are their opponents.

Also, NASA’s role in all of this is hidden by a powerful PR effort and propaganda, delivered by the mass media. The fact is that satellites with unspecified or dual capabilities (and “other” classified equipment) are delivered into space by them. The media focus on space stations, shuttle and mars/moon missions, deep space discoveries and so on ignores the fact that most of what’s up there is aimed down here, at us. That’s fine in relation to telecommunications, weather and reconnaissance satellites but NOT at all acceptable when referring to mind reading, neurophone, star wars or directed energy weapons; lethal or not.

The UN, The European Parliament and others want bans and treaties to outlaw these evil weapons but they’re treading lightly; afraid of disturbing the countries involved in these horrific programmes, especially the U.S.A. Surprisingly one of the best moves against these weapons was made in Michigan U.S.A where laws were passed recently outlawing the use of Electromagnetic weapons of any type on anyone (public acts 256 and 257). The penalty (ironically) is 15 years to life. Aside from the problems associated with enforcing such laws there remains the huge gap in international law, especially with respect to aerospace, satellites etc. Then, of course, there’s the problem of public ignorance and subsequent apathy on such matters, but it’s a start.

#### ETHIC CLEANSING:

Just as ethnic cleansing aims to eradicate those of a certain race or background many corrupt powerbrokers try to rid themselves of those with integrity, especially if they’re likely to question their criminal practices. Moral codes, honesty, fair-play, respect for the law and so on are encouraged publicly but privately (behind the “scenes”) they can be attacked where criminal, lucrative operations exist. Examples include satellite invasions of privacy, weapons proliferation, drug trafficking etc.

Agencies such as the DIA, CIA, MI6 and MOSSAD do the culling.

Money and control are the motives. They foster war, terrorism, drugs and any profitable blackmail friendly vices in conjunction with their crime syndicate partners. They are more than happy to trade our future for their short-term gains.

With respect to “prejudicial” or race specific type technologies it’s noteworthy that the DNA patterns within families have been found to be similar. So, whilst every new born, every corpse, prisoner, soldier, blood donor and so on is DNA tested/recorded their relative’s details may also be almost completely known by the controllers of the DNA banks. Research into controlling/injuring/”cleansing” certain sections of the community may well be under way already (ala the “smart” bombs and chemical weapons we know about already).

It is also important to remember here that Big Brother, in reality, is a criminal not a law enforcer. His associates/employees from different companies/sectors are complicit or controlled/blackmailed with information on their criminal or immoral practices; like paedophilia, rape, rorts, drugs, illicit affairs, money and more. Those not guilty of anything are affeared of public set ups/humiliation. Those working within the mass media itself are expected to participate in crimes against targets (mainly non public figures). So... by excluding honest, law-abiding people there remains little threat of anyone blowing the whistle on feedback/harassment crimes etc. All that does remain is a pool of influential public figures ready, willing and able to help criminally oppress their less fortunate fellow citizens and laugh about it (like a pack of sick, sadistic hyenas). By the way, soviet spy agencies apparently used to emphasise the value of such ridicule/laughter/derision in their spy courses. Humiliation and provocation can create an atmosphere conducive to entrapment for the unwary victim – false accusations of mental instability can also loom. Regardless these cruel attacks can be carried out by goon squads (spies, journo-terrorists, political “comedians” and other protected criminals) for many, many years in an unrelating campaign to destroy people of integrity.

The typical profile of an “ethic-cleansing” target is as follows: - They have no public identity and no connection whatsoever with anyone that does. They’ve drawn the attention of influential crooks through something they’ve said or done or written. Threats, blackmail, bribes, torture and so on prove ineffective but they inevitably suffer financially, have poor health and live less than average lives. Uncertainty as to blame or solution for their predicament can lead to itinerant, even self-destructive lifestyles. Sometimes those living with family find that they too can be harassed but those without a wife and kids rarely gain them after the covert attacks begin; especially if they’re subjected to neurophones and brainwave scans. For example, the harassment escalates whenever victims discuss or think about marriage because “they” don’t want that. It strengthens and legitimises support networks, leaves long-term evidence that contradicts the isolated, forelorn image they wish to create and removes many discrediting possibilities. Those who do marry often find pressures applied to destroy the relationship, including the sudden unemployment of the primary target and the increased harassment of the partner.

The major fear here for the cullers is that the target may not be isolated or discredited, worse still, they may gain the sympathy and support of loved ones. They prefer victims to keep moving; totally hapless. This reduces the likelihood that family, friends or investigators will believe their claims after they’re gone/dead. It also gives the mad scientists a free shot at these victims for as long as they like. The targets eventual

death often coincides with a timely breakthrough and can come courtesy of an agency or criminally introduced (or exacerbated) condition that “appears” to be natural.

Again, police, bureaucrats and so on are not officially informed of the covert agency methods. Those who learn during their career (and remain non corruptible) still lack the funds, personnel and equipment to help. Conscientious law enforcers who try to assist can be transferred, or worse, whilst corrupt/ignorant police remain. So the complainant usually faces frustration and possible discrediting at the hands of such officials. In addition there is the problem that law enforcers work for the government of the day, so if corrupt state or federal MPs are involved they and their cohorts will not be investigated for such covert crimes. Equally, the covert agencies (ASIS, CIA, MOSSAD, MI6 etc) cannot be questioned by even senior Federal police. The result is that where police smell a rat all they can do is mark files “politically sensitive” or something similar and wish the victim all the best.

#### THE WORLD OF ENTRAINMENT:

Entertainers “relay” messages; promoting certain lifestyles and ideas. Censoring, editing, creating subliminals and feedback are all part of the preparatory process. Because the mind can only absorb, store and regurgitate what it’s fed these methods are carefully worked.

The formal censorship procedure for pornography, violence etc, has limited success but the covert ones successfully mushroom most people. For example, publishing houses are controlled/monitored by criminals and agencies. Heavy editing, distribution/promotion controls and attacks on “banned” writers are common in relation to matters like satellite spying on ordinary citizens. The veneer of democracy allows a few to write about some things (revelations to the wider community) but not the bigger issues.

As a community we are also entrained from birth to accept that published works contain the truth. However, the full truth is often hidden. Even when the truth is placed in fictional works it can be tampered with during the publishing process. Even George Orwell, who penned the terms “Big Brother” and “thought police” and wrote many essays on censorship, was himself responsible for other writers being censored/banned when the information flow was tight.

As well as censorship we must be concerned about misinformation, lies of omission and emotional trickery. History books, for example, can be written under government grant and with government “instruction” as to slant and content. Now, students are discouraged from questioning texts. Only consumption and regurgitation of the relevant material ensures a student's survival/future. This is perhaps the reason that students are amongst the most difficult to convince when it comes to information and anecdotes which are not contained in black and white in textbooks or material which is spoon fed by educational institutions, government and media outlets.

With respect to major public misconceptions... Big Brother and his criminal associates arrange most of them. Whether it be the promotion of war or attitudes/fears regarding the New World terrorism, whether it concerns paedophile networks or cover ups on ocean predators, we all waste brain cells learning and espousing beliefs/opinions that flow from information that’s far from complete. Yet the misplaced trust given to those spreading this (mis)information makes us reluctant to dismiss it. We are

brainwashed into putting our faith in public figures who are undeserving of that faith. These “actors” are from a privileged socio-economic class which profits from misleading the general population on certain matters and most of them do not care.

So, the concept of a truly fair, democratic society is only an unrealized dream. This is due to the betrayals of those whose integrity has been eroded, courtesy of anything from money to drug dependency to gross sexual immorality to murder. This then leads to silence/acceptance regarding crimes committed against advocates of the truth; crimes like satellite voyeurism, journo-terrorism and mental rape. And the worst of these people will actually participate in such crimes.

#### THE INSTITUTIONALISED:

For phoney/hypocritical public figures who are confronted with the ugly truth false accusations of insanity or villainous intent are a convenient means of disposing of the source of that truth, without the guilt associated with murder. Psych operators, corrupt law enforcers and high tech satellite weaponry make this all too easy and common.

At one extreme, some targets of neurophone and brain scanning technologies can actually go crazy which tarnishes the reputation/credibility of other victims and creates covers and excuses for those monitoring/provoking the targets. Also, violent targets can hurt innocent people in what is not so much a random act but a calculated scenario of agency terrorism (using targets as Manchurian candidates). Psychopaths Timothy McVeigh and Martin Bryant were triggered in this way but their tormentors should share their fate. That’s equally true with regard to provocateurs of any sort, especially re terrorism. As for the frightened/uncaring/complicit on lookers – well they are leaving the door open for many similar atrocities by remaining silent. There can be no adequate excuse for such selfishness.

Now, people committed to asylums, imprisoned or housed in nursing homes are sitting ducks for illegal research even though today’s Dr Mengeles use cross sections of the community for their evil studies. A prime example is the NSW jail system. Many state jails house victims of illegal government and private research mostly facilitated by American interests. Some, like Junee jail, have been privatized with hand picked prisoners being subjected to neurophone and brain scanning experiments; remotely via satellite. The Department of Corrective Services and The Health Department do not protect the guinea pigs. In fact, prison psychiatrists gleefully record that a very high percentage of each prisons population are paranoid schizophrenics; hearing voices. The truth is many are violated and tortured in one of the most intensive, inhuman experiments ever devised. The aural/mental torture and brain rape is doubly frustrating for these poor wretches thanks to the psych operators misdiagnoses. With so many “supposed” schizophrenics an investigation is obviously in order but, of course, there won’t ever be one. In fact when they’re released prisoners who seek help outside inevitably die e.g. Peter Schneidas, who believed he was listening to God.

Those provoked/tricked into committing crimes can be dealt with summarily by Kangaroo courts, corrupt judges, lawyers, etc. Many “victims turned victimizer” are killed or driven to suicide. A recent sad example was the case of police whistleblower, Scott Simpson. He was thrown into a jail cell at Goulburn jail, drunken/drugged. The paedophile he was wrongly paired with was dead 10 minutes later. Scott “supposedly”

killed him but could remember nothing. His “three week jury trial” was held in private, over just three days with the jury summarily dismissed because the matter was “supposedly” too complicated for the average citizen to understand (even though at a pre trial hearing another jury had decided that Scott was fit to plead, believing his explanations about the neurophone/brainscan harassment and even challenging the government psychiatrists present over their “supposed” ignorance of that technology). So, in the trial proper the verdict was not guilty by reason of mental disorder (insanity). This despite the fact that Scott had instructed his solicitors to plead manslaughter but was ignored, much to the annoyance of one observer who, I’m told, was removed from the court for pointing this out.

Next, Scott was placed in segregation/solitary for 23 hours a day (at Long Bay jail). This continued for 2-3 months after the trial and looked like continuing. As a “forensic” inmate he was entitled to better/freer treatment but The Supreme Court trial papers, which are usually onforwarded to the Mental Health Review Tribunal within 2 weeks, were not sent at all despite frequent requests from the Tribunal and Scott’s mother. Tribunal and Legal Aid representatives were unable to help Scott as all efforts to gather the court papers and hold a Tribunal hearing were thwarted. Finally, when his jailors removed his correspondence/call rights (and totally isolated him), Scott “supposedly” gave up and killed himself on June 7<sup>th</sup>, 2004, still in solitary. At the time he was enquiring about suing the Department of Corrective Services for the mistreatment and planned to write his own story as well as help other inmates with similar problems; to cope with the illegal research. Oh, and the court papers? They had been archived well before Scott died, never to be passed on, just as if he was dead on the day of the trial.

Although the remote high tech problems mentioned here are monstrous, traditional horrors like electric shock therapy, trans-orbital leucotomy and frontal lobotomy have confronted unfortunate asylum “patients” for many years. Recently a form of shock therapy was promoted even for mild cases of depression... follow the research/money trail there to understand mans inhumanity to man even better. The fact is, the soviets may have originated political psychiatry (deliberately misdiagnosing and mistreating patients who are targeted by criminals) but western science has perfected it. The intrusive and often falsified analysis of thoughts, dreams, memories, opinions, fears, joys and ideas helps these monsters in their crimes/careers. As for (mis)treatment with psychotropic drugs, that only turns the victim into a zombie whether they’ve rightly complained about high tech interference or not. “They” realise all of that but helping is not what they’re all about. The ultimate attitude is illustrated by the U.S. desert testing of nuclear weapons where asylum “patients” were used as guinea pigs. I wonder how many were “political” targets.

Nursing homes are also targeted. Some old war refugees, whistleblowers etc are still covertly tormented from remote locations by enemies; known or unknown. They are demented and so they’re now easily ignored. Questioning powerful government/corporate/agency interests over the matter is pointless.

Finally, an illustration of the role played by psychiatrists and institutions in the past. In times long gone, when the “lady of the house” became menopausal her unsympathetic, lecherous old husband could have her put in an asylum and take up, full time, with his mistress. All the poor woman would have to do was complain a little or

shed a few tears and it was “oh dear, she’s having a nervous breakdown.” Understanding of the natural transition all women go through has put that arrant nonsense in the past but people do not change, only circumstances. Today’s unscrupulous tyrants think nothing of dismissing as mad a female who, say, presents information on paedophile networks but succumbs to pressure long enough to shed tears. Again, nothing has changed. In fact it’s worse. Powerful people still have nuisances/enemies destroyed or institutionalized wherever and whenever possible. The shadowy vipers responsible often deliver the victims into the hands of amoral scientists to protect their criminal operations (and themselves) from even the slightest of criticisms. The more guilty the villain the more desperate the knee jerk response. “He/she’s mad” being the most desperate yet damaging response of all. And what can the victim do or say when there’s no physical evidence and a conspiracy of silence.

#### SUMMARY/OBSERVATIONS:

Hypocrites in lofty positions may pretend to support the truth and promote true democratic rights but many will stifle both truth and democracy whenever it’s convenient. If covert harassment/torture is the price you pay for exercising your so-called “rights” then free speech (freedom of expression of any sort) isn’t really free at all and neither are we.

The truth is that democracy, like many of our public figures, is not the genuine article. It’s only an illusion we are entrained to believe by wealthy criminals who use it like phoney religions or illicit drugs or any other satiating, controlling mechanism. Justice and equity, (pseudo democracy) are only accessible if you have real money and agree entirely with your fellow class criminals. It’s as if each of them has heard a subliminal whisper; “It’s yours but you’re mine” and jumped at the chance. They then look at the honest majority in a smug fashion. Having excluded that majority they then spy on some of them to gauge how honest, decent people feel and think and how they can best be deceived... all at arms length.

Corruptible professionals, including politicians, journalists, psychiatrists, lawyers and more will rubber stamp whatever their clients/masters/employers dictate. In other words, their “opinions” are for sale. They’re “guns for hire”; mercenaries. A journalist, for example isn’t going to run a story on unregulated, illegal media surveillance; a psychiatrist isn’t going to declare a government whistleblower sane if paid to say otherwise; a divorce lawyer won’t recommend marriage counseling, (avoiding costly court proceedings); a vet won’t report on the ill health of ex racing animals if his primary income source is the racing industry itself... and so on. It’s a lack of professional and personal ethics at work here and self-delusion covers it all. For instance, the trial judge in the Timothy McVeigh case refused to even admit evidence of covert agency operations relating to McVeigh (including neurophone provocation and trickery) because he refused to accept that his country would do such a thing. Think honestly about that one and you’ll be sick. Look, if honesty was the norm the genuine errors and injustices would be few. Unfortunately, attitudes to crime are selective and class prejudiced, especially amongst many of our “esteemed” community leaders.

On the brainwashing effected by psych’ operators (throughout the community)... different emotions, habits, beliefs, opinions, cultures, political persuasions etc are usually only like different aspects of our character/personality; none necessarily relates to mental

health. To expect textbook (similar or same) responses is intolerant and simplistic. E.g. anger is often justified when a calm, secure response may be deceitful, only hiding the truth, say in a TV interview. An innocent target may be provoked plus any tape can be edited and so on to discredit him/her. Regardless, there are many entertainers who, with public pressure and more, resort to psych support. This encourages others to do likewise and also elevates the psych profession above its rightful position; giving it control over many peoples futures. Accordingly, as part of the harassment overkill, many victims have suffered the ignominy of psych operator discrediting as well as other mishaps.

Powerful criminals want to operate without fear of challenge, so it's not surprising that they use agency connections and vice versa. Equally the new terrorism focus comes at the expense of domestic/international crimes which could be wiped out if access to the relevant satellite equipment was given to the appropriate agency operatives and law enforcers. Instead the protectors of this whole treacherous arrangement (amounting to class warfare against the great unwashed) hone their sadistic skills as liars, terrorists and torturers by using advanced, evil technologies to brainwash and herd deserters into line. The rest (the majority) are indoctrinated with standard life plans and goals run through the mass media.

Just as our elected representatives do not have a mandate to lie or foster/harbour criminals equally the media shouldn't be able to operate as "watchdogs" without independent regulation. Without scrutiny they've become a powerful force for oppression, suppression, misinformation and more; often a sinister element rather than acting for the good of the general public (the majority). Again, the media even use their surveillance/harassment targets as sources of inspiration, ideas and opinions which keeps them in touch with the common people, assists them to understand the ways of decent, honest citizens and allows them to study which deceptions work best on the skeptics. Similarly the leaders of hierarchies (within churches and bureaucracies etc) learn how to silence people using these same shameful, sinister methods, facilitated by U.S. technology.

In any event, tyrannical treatment has been meted out to concerned citizens worldwide for centuries. It will remain unacceptable and indefensible but they'll continue to hide many truths by persecuting and setting up the true advocates of peace, equity, morality, integrity and democracy. And in case the reader is apathetic about all of this, remember that just as the Echelon satellite system allows computer analysis of all telecommunications today, tomorrow the brainwave monitoring systems will expand to the level where everyone's thoughts can be monitored for key opinions/ideas etc. Failure to realise that will mean that the real, criminally motivated thought police will grow in strength and influence. This will result in total mental enslavement, for all of us.

Finally, due to global escalation of terrorist activities, military/agency funding levels have increased astronomically, along with the relevant laws. However, modern technology can pinpoint and neutralize all criminals including terrorists. We must then question the spy agencies allocation of funds and misuse of those same funds to effect illegal harassment and torture of honest citizens, the theft of intellectual property via mental rape and all manner of "control" research sponsored by wealthy criminals. The token criticisms allowed from people like Michael Moore and John Pilger will not be enough for the silent (or silenced) majority which they represent. Others should also be allowed to speak up, on our behalf, to give weight to the truth.

## CONCLUSION:

We must challenge the validity of any and all information which is supplied by “actors” on the world stage, especially mainstream journalists and politicians. The superior/corrupt attitude of the ruling class excludes all character, integrity, honesty or truth on too many vital issues. Criminal protection by psych operators and others remains unreported and so people can be easily brainwashed into respecting/trusting criminals in high places. In particular a shadow of evil hangs over the entertainment industry and politics wherein many deceive the general population both freely and often. We are being conditioned: told to function but not think.

Those who speak out (or try to) about this can be ruined and discredited, especially as we’ve been entrained to believe that “successful”, wealthy people are to be admired and emulated. Unfortunately many are nothing more than talented criminals. Most people have their price, they say, so a doctor will endorse smoking if paid enough by a tobacco company to do so; police will frame innocent people for remuneration/favour; psychiatrists will brand sane men as mad for the same reason and journalists will fabricate and sell a warped story to the public to destroy the reputation of genuinely concerned citizens who dare to question evil in high places. We must see this clearly and not be fooled.

In a world troubled by a lack of natural resources, stricken with disease, poverty and famine, ravaged by war, terrorism AND MORE it’s obscene that carefree criminals should actually profit from the misery of their fellow man let alone be allowed to crucify (at will) those who question them. The self serving and intolerant will no doubt continue to prosper, on blood money etc but they cannot seriously expect our trust/respect in return. This is especially so for those who have been covertly and criminally spied on, harassed, tortured and mind raped. The tormentors do not care for the spirit of the law, the truth, the people or the future. They have betrayed themselves and all of us. I would not want to be in their place awaiting judgement.
